



**Travel and subsistence expenses for the period of 1st April 2020 – 30 June 2020
(Re-employed Retired Sheriffs Principal, Sheriffs and Part-time Sheriffs,

The above judicial office holders sit when required to assist with heavy workloads and provide cover for permanent judicial office holders who are absent.

Part-time sheriffs may sit in any court in Scotland and consequently the very nature of the role can involve a considerable amount of travel. Other part-time judicial office holders may also be required to travel in the manner of their permanent counterparts. Re-employed retired sheriffs may hold a similar role to that of a floating or part-time sheriff.
